



## THE KIWIFRUIT CLAIM

### The Kiwifruit Claim

#### COURT UPDATE 15 SEPTEMBER 2017

The High Court trial in Wellington has now completed its sixth week.

This week the Court heard evidence from two Crown witnesses. First up was former MAF/MPI staff member, Gerard Clover, who in his role with the Plant Health and Environment Laboratory, supervised the internal MAF literature review on plant pests and diseases transmitted by pollen. Gerard Clover's evidence focussed on the import health standard for nursery stock, and the internal literature review which was relied on by MAF when the first permit to import kiwifruit pollen was issued.

The Court also heard from Stephen Butcher who was the Manager of the Plant Imports and Exports Group at MPI, who oversaw the development of import requirements for plant products. His evidence covered how import standards are set in New Zealand and the factors that MPI would consider when setting an Import Health Standard.

Your legal team believe that during their cross examination they successfully highlighted deficiencies in the MAF/MPI processes for the Court to consider.

### **TRIAL TIMETABLE GOING FORWARD**

The lawyers keep us updated on the likely timetable for the trial, and as previously advised it is expected that we will not need all the 13 weeks currently scheduled. This will depend on how long each witness is required to give evidence and how many questions they are required to answer. While it is not possible to give exact times and dates, the remainder of the trial is expected to run as follows:

- 18 September – The Crown will continue to present its witnesses, and they will be cross examined by our lawyers.
- 30 October (potentially earlier)– The Crown closes its case.
- Late October - Our lawyers close our case, and the trial is scheduled to finish.
